#### German Shepherd Dog Federation of Southern Africa

Dear Sir, Dear Madam,

our WUSV membership association, the German Shepherd Dog Federation of Southern Africa requested us to clarify the matter in the form of a few points.

Both you and the signatory have been aware of the turbulent history between the WUSV and the German Shepherd Dog Federation of Southern Africa since the time of Dr. Rummel. Of decisive importance for the WUSV are the agreements reached between your organisation and the German Shepherd Dog Federation of Southern Africa, to which the WUSV is also abiding. In summary, this has resulted from the intention to enable a sound collaboration between the umbrella association and the German Shepherd Dog Federation of Southern Africa for the benefit of the breed of the German shepherd dog. The signatory does not view it to be necessary to fill the files with yet more correspondence, but to adhere to the result. From their point of view, on the basis of the best possible cooperation, the result was that in the context of matters concerning the German shepherd dog, the German Shepherd Dog Federation of Southern Africa is to be contacted and that this organisation is to provide its agreement as to when the steps which are pursued or the judge invitations should take effect. This means that in the event of invitations of judges from the mother country through KUSA, the agreement of the German Shepherd Dog Federation of Southern Africa will be demanded by the WUSV. In addition to this, it is also the case that knowledge or materials of the SV or WUSV associations cannot be accepted without permission. We also assume that this situation is satisfactory to you; if only one association is responsible for one breed, as you have agreed. According to our knowledge, the German Shepherd Dog Federation of Southern Africa has not contravened any of the agreements.
